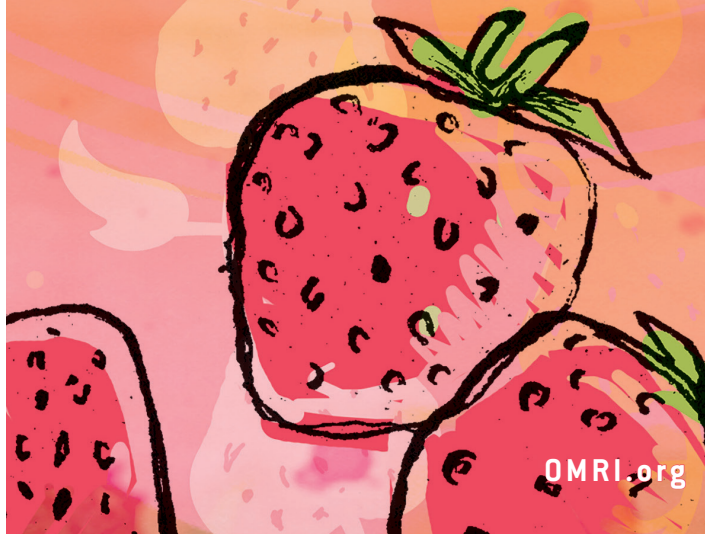

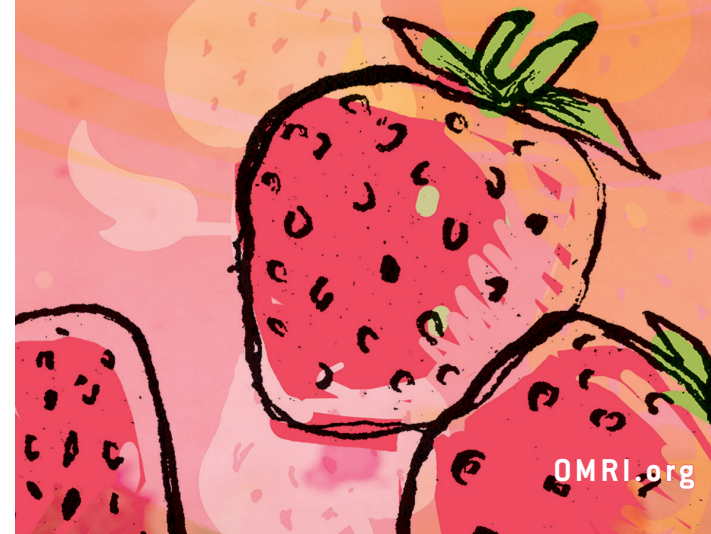

Are OMRI Listed products “certified organic”?

Only food and fiber products can be certified organic under federal law. The OMRI seal means that an “input” product, such as a fertilizer or pest control product, meets organic standards and is allowed for organic use.

How does OMRI know what's in a product?

Product suppliers show their commitment to organics by voluntarily submitting an OMRI application with complete product information. Around 10% of the applications are rejected, usually due to an unknown or noncompliant ingredient.
