

How Does it Work?

Step 1 • Input suppliers can visit OMRI.org/apply to start the process. After paying a small fee to register the company with OMRI, applicants receive access to all of the resources needed to apply.

Step 2 • OMRI collects complete product information and an application fee, using a sliding fee scale in order to support large and small businesses alike.

Step 3 · OMRI confidentially reviews product information for compliance with the organic standards (e.g., the Canada Organic Regime, U.S. National Organic Program standards and/or Mexico Organic Products Law).

Step 4 • OMRI's Review Panel makes a final decision as to whether the product meets the applicable standard.



Step 5 • Allowed products are listed at OMRI.org and may use the OMRI Listed[®] seal, delivering instant recognition for compliant products and simplifying the process for organic producers, processors and certifiers.



The OMRI Listed seal signifies that an input product meets the U.S., Canadian or Mexico organic standards. Organic users should check OMRI.org for further information on compliant uses.
