The Sokol Blosser Winery received organic certification in 2005, and won *Sunset Magazine's* Green Award for pioneering environmental practices in the 2007 Western Wine Awards.

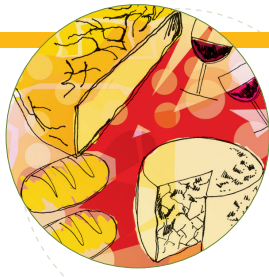
